To: The Idaho Legislature and the Citizens of Idaho

Re: The Prosecution of Child Sexual Abuse

With this letter, we submit the annual report for Fiscal Year 2020 on the prosecution of child sexual abuse in Idaho.

During FY2020, the total number of reported incidents of child sexual abuse in Idaho increased by 17-percent, with an additional 115 incidents reported compared to FY2019. This increase is slightly less than the 22-percent increase we reported for FY2019. Additionally, the total number of child sexual abuse cases filed in Idaho in FY2020 was 973, an increase of 277 cases compared to FY2019. That was the highest number of cases filed since this report was first completed in FY1990.

We do not know whether these high numbers can be attributed to Idaho's growing population, whether societal factors are somehow contributing to more sexual abuse of children, or whether there are other factors of which we are not aware.

We must continue to dedicate ourselves and our resources to combating this problem. Our efforts must start in the home, but they must also include the extended family, churches, schools, community associations and law enforcement. As to the latter, we must work together to provide tools necessary for our law enforcement officers and prosecutors who are on the front lines of the battle against child sexual abuse. Idaho's children deserve no less.

Incidents:

IN FY19-FY20, 775 INCIDENTS OF CHILD SEXUAL ABUSE WERE REPORTED TO THE DEPARTMENT OF HEALTH AND WELFARE, DIVISION OF FAMILY AND COMMUNITY SERVICES. I.C. § 67-1405(1). THIS REPRESENTS AN INCREASE OF 115 MORE INCIDENTS REPORTED SINCE FY19.

A TOTAL OF 973 CHILD SEXUAL ABUSE CASES WERE FILED (784 ADULT CASES, 189 JUVENILE PETITIONS) IN IDAHO DISTRICT AND JUVENILE COURTS IN FY20. THIS REPRESENTS AN INCREASE OF 277 MORE CASES FILED SINCE FY19.

CONVICTIONS WERE REPORTED IN CHILD SEXUAL ABUSE CASES THAT INCLUDED: 93 ADULT OFFENDERS RECEIVING PRISON, AND 10 JUVENILE OFFENDERS COMMITTED TO THE CUSTODY OF IDJC; THERE WERE 51 ADULTS AND 82 JUVENILES PLACED ON PROBATION; AND 39 ADULTS WERE GIVEN RETAINED JURISDICTION. HISTORICAL OVERVIEW OF ANNUAL REPORT

WITH THE PASSAGE OF HOUSE BILL 362 IN 1989 (ADDING SECTION 67-1405 TO THE IDAHO CODE), THE DUTIES OF THE ATTORNEY GENERAL WERE EXPANDED TO INCLUDE PREPARATION OF AN ANNUAL STATISTICAL REPORT REGARDING CHILD SEXUAL ABUSE IN IDAHO. THE ANNUAL REPORTS PRESENTED TO THE IDAHO LEGISLATURE SINCE 1990 ARE AVAILABLE AT <HTTPS://WWW.AG.IDAHO.GOV/OFFICE-RESOURCES/SEXUAL-CHILD-ABUSE-REPORTS/>.

THE COLLECTION OF DATA AND PREPARATION OF THIS REPORT FOR FY20 IS THE RESULT OF THE ATTORNEY GENERAL'S STAFF EFFORTS TO PREPARE A REPORT THAT COMPLIES WITH THE STATUTORY DIRECTIVES OF I.C. § 67-1405. THIS REPORT IS JOINTLY SUBMITTED BY GOVERNOR BRAD LITTLE AND ATTORNEY GENERAL LAWRENCE WASDEN.

DATA COLLECTION PROCESS

THIS REPORT INCLUDES DATA ON “INCIDENTS” OF CHILD SEXUAL ABUSE REPORTED TO THE DEPARTMENT OF HEALTH AND WELFARE IN FY20 (JULY 1, 2019 TO JUNE 30, 2020), THE ADULT AND JUVENILE CHILD SEXUAL ABUSE CASES FILED BY COUNTY PROSECUTORS IN FY20, THE DISPOSITIONS OF THE CHILD SEXUAL ABUSE CASES DURING THAT PERIOD, AND INFORMATION CONCERNING THE DISCHARGE OF INMATES WHO WERE CONVICTED OF CHILD SEXUAL ABUSE CRIMES. THE PROCESS OF GATHERING INFORMATION INCLUDED IN THIS REPORT WAS INITIATED AT THE CLOSE OF THE FISCAL YEAR IN JULY 2019.

IN KEEPING WITH THE INTENT OF I.C. § 67-1405, THE OFFICE OF THE ATTORNEY GENERAL COLLECTED DATA THROUGH SYSTEMS AND PROCESSES PRESENTLY UTILIZED BY THE CONTRIBUTING GOVERNMENTAL ENTITIES. FOR EXAMPLE, INFORMATION CONCERNING THE REPORTING OF CHILD SEXUAL ABUSE INCIDENTS WAS GATHERED FROM “FACTS, FIGURES, TRENDS, 2019-2020: A REPORT PREPARED BY THE IDAHO DEPARTMENT OF HEALTH AND WELFARE.” FY20 CASE AND DISPOSITION INFORMATION WAS INITIALLY OBTAINED THROUGH THE SUPREME COURT’S STATEWIDE CASE MANAGEMENT DATABASE AND THEN PRESENTED TO EACH COUNTY PROSECUTOR’S OFFICE FOR REVIEW AND VERIFICATION. DISCHARGE AND PAROLE RELEASE DATA WAS COLLECTED FROM EXISTING COMMISSION OF PARDONS AND PAROLE DATA FOR FISCAL YEAR 2020.

IN THIS REPORT, THE OFFICE OF THE ATTORNEY GENERAL HAS ENDEAVORED TO COLLECT AND INCLUDE CHILD SEXUAL ABUSE DATA PERTAINING TO: (1) INCIDENTS; (2) CASES; (3) DISPOSITIONS; AND (4) DISCHARGED INMATES AS REQUIRED BY I.C. § 67-1405. THIS REPORT INCLUDES CASES INVOLVING THE FOLLOWING STATUTORY SEXUAL OFFENSES INVOLVING CHILDREN:

- INJURY TO CHILDREN (I.C. § 18-1501);
- SEXUAL ABUSE OF A CHILD UNDER THE AGE OF SIXTEEN YEARS (I.C. § 18-1506);
- RITUALIZED ABUSE OF A CHILD (I.C. § 18-1506A);
- SEXUAL EXPLOITATION OF A CHILD (I.C. § 18-1507);
- POSSESSION OF SEXUALLY EXPLOITATIVE MATERIALS (I.C. § 18-1507A);
- LEWD CONDUCT WITH A MINOR CHILD UNDER SIXTEEN (I.C. § 18-1508);
- SEXUAL BATTERY OF A MINOR CHILD SIXTEEN OR SEVENTEEN YEARS OF AGE (I.C. § 18-1508A);
- ENTICING OF CHILDREN (I.C. § 18-1509); AND
- ENTICING OF CHILDREN OVER THE INTERNET (I.C. § 18-1509A).

CONSISTENT WITH THE STATUTORY MANDATE, THIS REPORT INCLUDES ONLY INFORMATION AVAILABLE THROUGH EXISTING SYSTEMS AND RESOURCES RELATING TO REPORTED INCIDENTS, CASES FILED, DISPOSITIONS, AND OFFENDERS DISCHARGED IN CHILD SEXUAL ABUSE CASES INVOLVING THE ABOVE STATUTORY SECTIONS.

REPORTED INCIDENTS
I.C. § 67-1405(1)

IDAHO CODE § 67-1405(1) PROVIDES:

THE DEPARTMENT OF HEALTH AND WELFARE, EACH CITY POLICE DEPARTMENT, EACH COUNTY SHERIFF AND THE IDAHO STATE POLICE SHALL SUBMIT TO THE OFFICE OF THE ATTORNEY GENERAL A REPORT OF EACH CHILD SEXUAL ABUSE INCIDENT REPORTED TO EACH AGENCY OF STATE OR LOCAL GOVERNMENT. THE REPORT SHALL CONTAIN SUCH INFORMATION AS SPECIFIED BY THE ATTORNEY GENERAL. IT SHALL BE THE DUTY OF THE ATTORNEY GENERAL TO THE GREATEST EXTENT POSSIBLE TO USE AND DEVELOP THE INFORMATION REQUIRED IN THIS SECTION ON FORMS CURRENTLY IN USE BY EACH GOVERNMENTAL ENTITY, THUS AVOIDING UNNECESSARY PAPERWORK.

IN THIS REPORT, THE OFFICE OF THE ATTORNEY GENERAL HAS INCLUDED THE CHILD SEXUAL ABUSE INCIDENT DATA REPORTED BY THE DEPARTMENT OF HEALTH AND WELFARE¹ FOR FY07-FY20, WHICH IS SUMMARIZED AS FOLLOWS:

THESE STATISTICS DO NOT INCLUDE INCIDENTS OF CHILD SEXUAL ABUSE WHICH MAY HAVE BEEN REPORTED TO LAW ENFORCEMENT BUT DID NOT INVOLVE THE SERVICES OF THE DEPARTMENT OF HEALTH AND WELFARE.²

² The Attorney General recognizes that some "incidents" of child sexual abuse may be reported to local law enforcement entities but not reported to or investigated by the Department of Health and Welfare; however, there are no systems presently in place to identify such reports or to account for duplicate reporting of the same incident. Therefore, incident information included in this report is limited to those incidents of child sexual abuse reported to and investigated by the Department of Health and Welfare.

IT SHALL BE THE DUTY OF EACH COUNTY PROSECUTING ATTORNEY TO SUBMIT TO THE OFFICE OF THE ATTORNEY GENERAL A REPORT OF EACH CHILD SEXUAL ABUSE CASE HANDLED BY THE PROSECUTING ATTORNEY. THE REPORT REQUIRED PURSUANT TO THIS SECTION SHALL BE DESIGNED BY THE ATTORNEY GENERAL TO MINIMIZE THE PAPERWORK IMPACT ON EACH COUNTY PROSECUTOR.

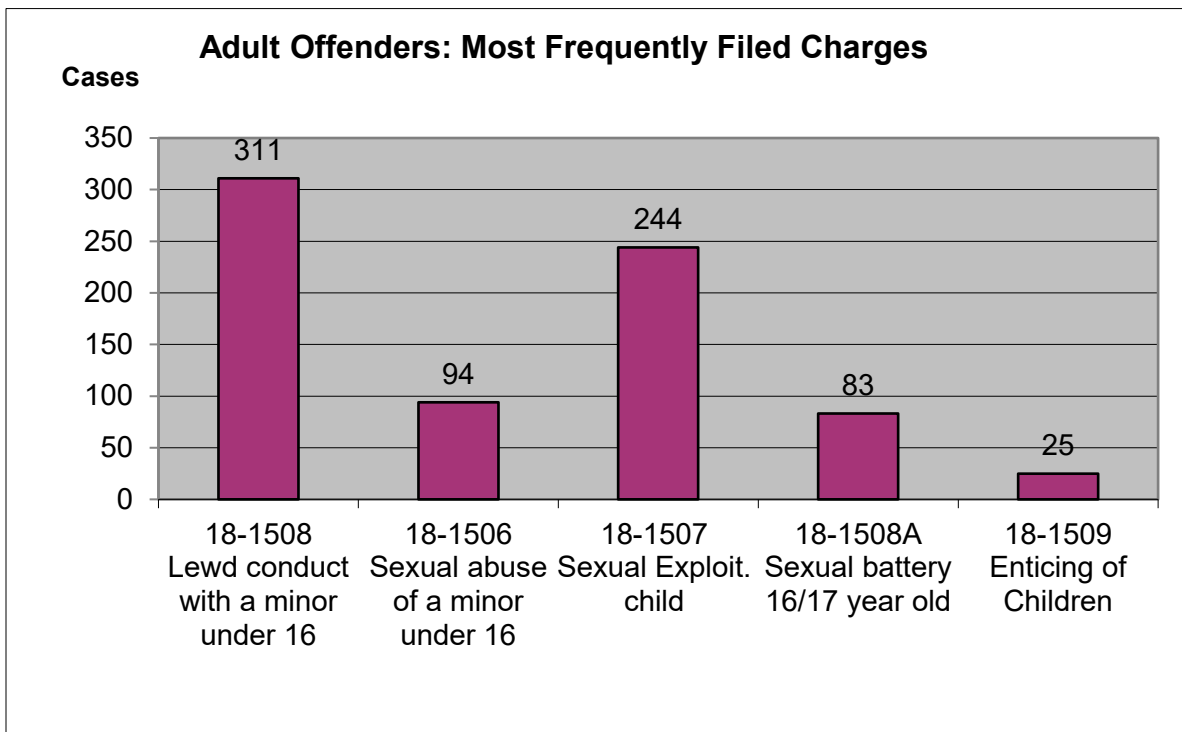
A. SUMMARY OF ADULT CASES FILED

ADULT OFFENDERS: CASES AND CHARGES FILED

INFORMATION ON THE ADULT CASES FILED IN FY20 IS INCLUDED IN **CHARTS A1 AND A2**. A TOTAL OF 784 ADULT CASES WERE FILED IN DISTRICT COURT DURING THE TWELVE-MONTH PERIOD FROM JULY 1, 2019 - JUNE 30, 2020.

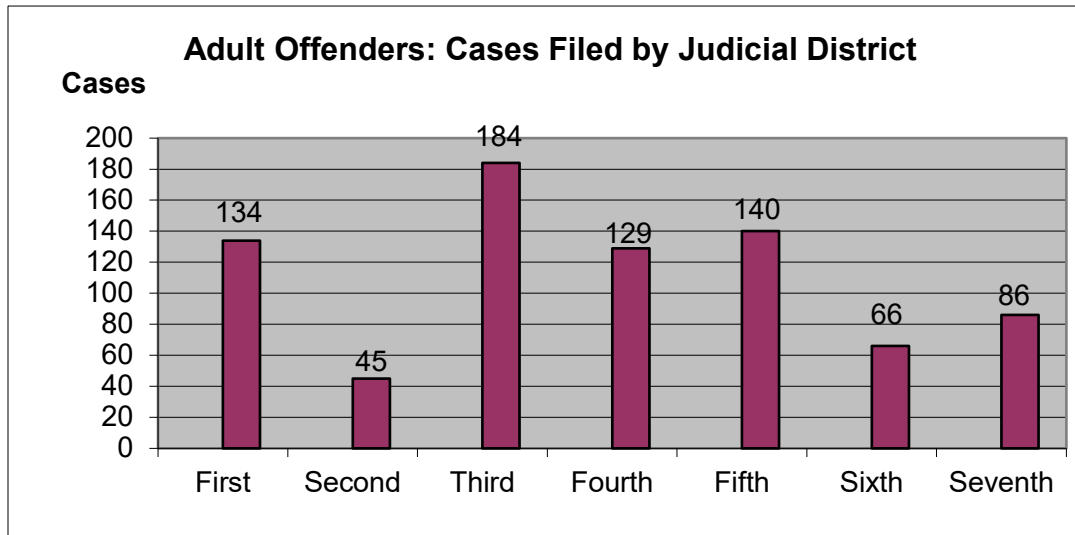
CHART A1: MOST FREQUENTLY FILED CHARGES



LEWD CONDUCT WITH A MINOR CHILD UNDER SIXTEEN (I.C. § 18-1508) CONTINUES TO BE THE CHARGE MOST FREQUENTLY FILED, REPRESENTING 41% OF THE CHARGES FILED IN THE 784 ADULT CASES.

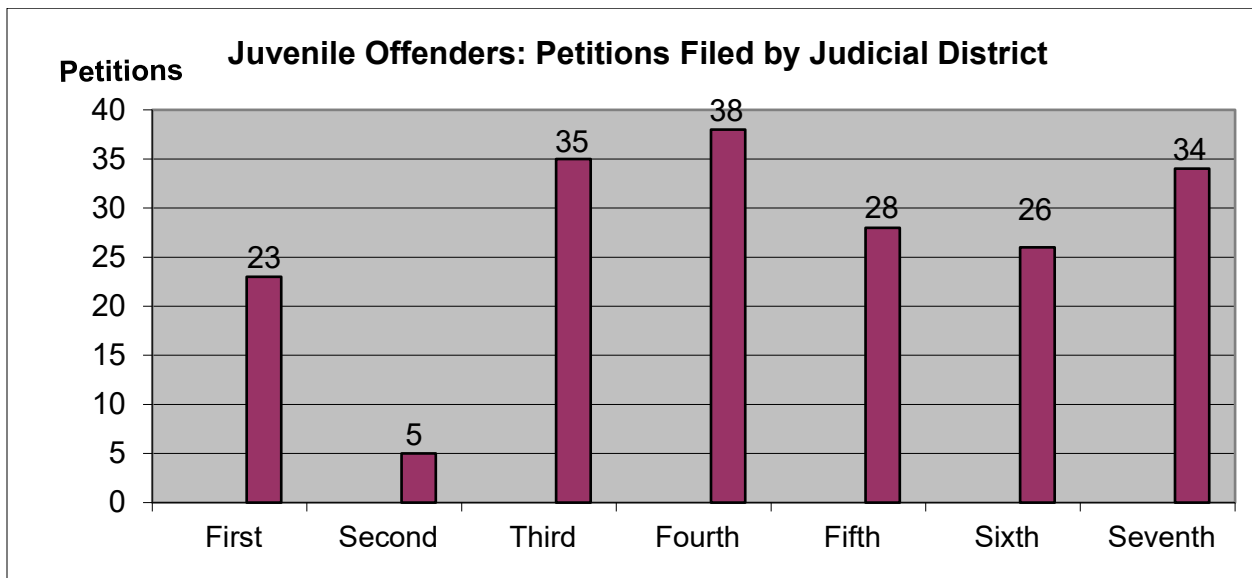

JUVENILE OFFENDERS: PETITIONS FILED

ALL BUT 32 OF THE 189 JUVENILE PETITIONS REPORTED IN FY20 CHARGED LEWD CONDUCT WITH A MINOR CHILD UNDER SIXTEEN (I.C. §18-1508). THUS, LEWD CONDUCT WITH A MINOR CHILD UNDER SIXTEEN (I.C. §18-1508) IS CLEARLY THE PREDOMINANT CHARGE IN CHILD SEXUAL ABUSE CASES WHERE THE OFFENDER IS A JUVENILE.

DISPOSITION INFORMATION
I.C. § 67-1405(3)

IDAHO CODE § 67-1405(3) PROVIDES:

THE ADMINISTRATIVE OFFICE OF THE COURTS SHALL SUBMIT TO THE OFFICE OF THE ATTORNEY GENERAL A REPORT SHOWING THE DISPOSITION OF EACH CHILD SEXUAL ABUSE CASE HANDLED BY EACH OF THE DISTRICT COURTS THROUGHOUT THE STATE. THIS REPORTING REQUIREMENT MAY BE SATISFIED BY SUBMISSION OF A COPY OF A JUDGMENT MADE AND ENTERED IN EACH CASE.

A. SUMMARY OF DISPOSITIONS FOR ADULT CASES FILED IN FY20

ADULT OFFENDERS: DISPOSITION INFORMATION

CHART A3 SHOWS THAT IN FY20, CONVICTIONS WERE OBTAINED IN 182 CHILD SEXUAL ABUSE CASES WHERE THE OFFENDER WAS AN ADULT; DISMISSALS WERE ENTERED IN 196 CASES AND 403 CASES REMAIN PENDING.

CHART A3: SENTENCING DISPOSITIONS

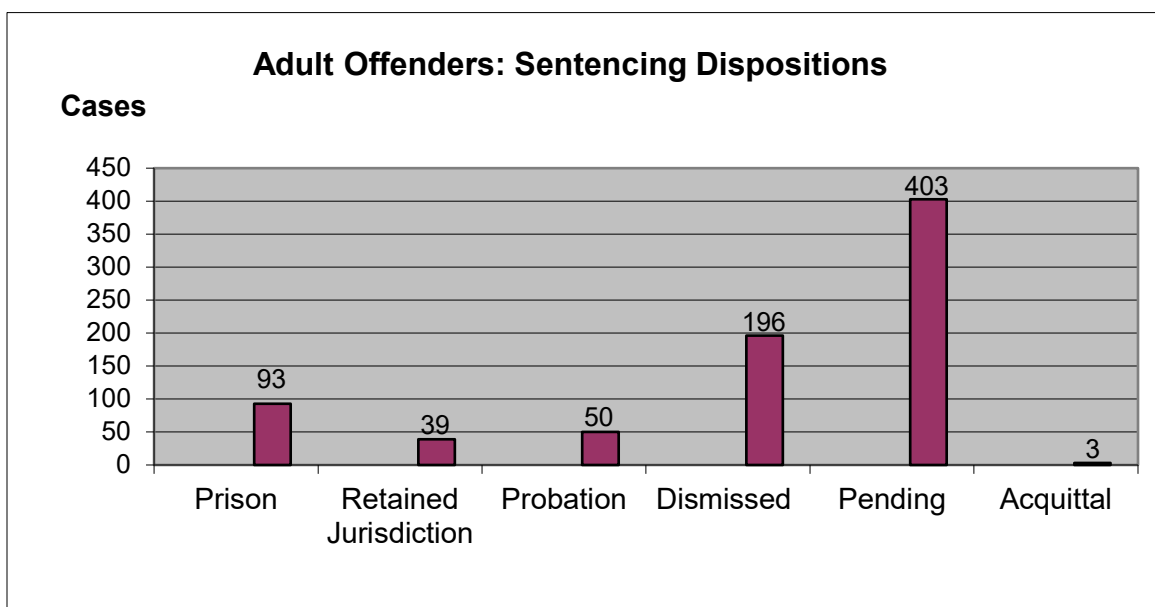


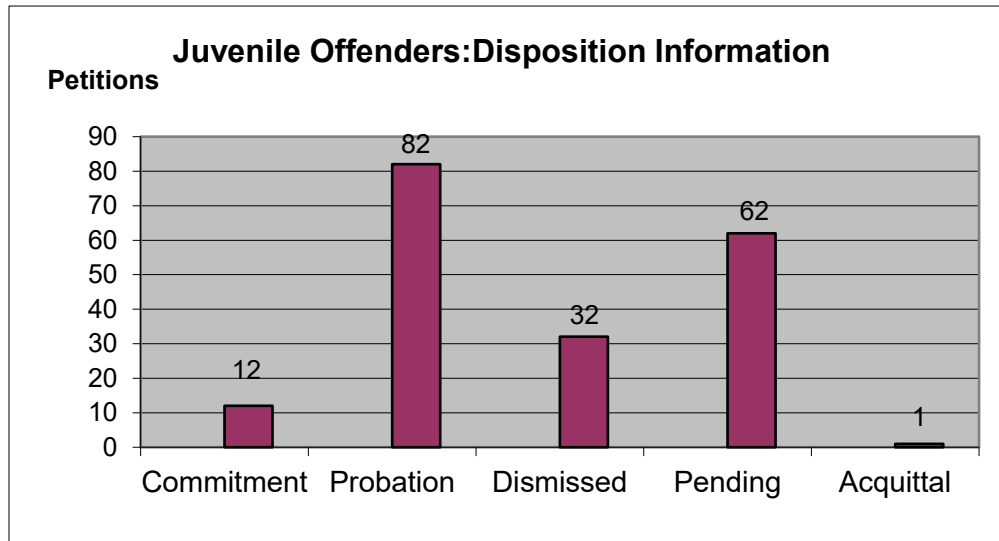
CHART A3 ALSO SHOWS THAT OF THOSE CONVICTED IN FY20, 93 ADULTS (51%) WERE SENTENCED TO PRISON; 39 ADULTS (21%) WERE GIVEN RETAINED JURISDICTION; AND 50 ADULTS (28%) WERE PLACED ON PROBATION.

B. SUMMARY OF DISPOSITION INFORMATION FOR JUVENILE OFFENDERS

JUVENILE OFFENDERS: DISPOSITION INFORMATION

CHART J2 SHOWS THAT OF THE 94 JUVENILES DISPOSITIONED IN FY20 IN CHILD SEXUAL ABUSE CASES, PROBATION WAS GRANTED IN 82 CASES (87%), AND 12 JUVENILES (13%) WERE COMMITTED TO THE CUSTODY OF THE IDAHO DEPARTMENT OF JUVENILE CORRECTIONS.

DISCHARGED OFFENDERS
I.C. § 67-1405(4)

IDAHO CODE § 67-1405(4) PROVIDES:

THE COMMISSION ON PARDONS AND PAROLE SHALL SUBMIT TO THE OFFICE OF THE ATTORNEY GENERAL A REPORT SHOWING THE RELEASE OR DISCHARGE OF ANY INDIVIDUAL CONVICTED OF A CRIME INVOLVING CHILD SEXUAL ABUSE. SUCH REPORT SHALL BE DESIGNED TO MINIMIZE THE PAPERWORK IMPACT UPON THE COMMISSION.

THE COMMISSION OF PARDONS AND PAROLE REPORTED THAT DURING THE 2020 FISCAL YEAR, IT GRANTED PAROLE TO 256 INMATES AND DISCHARGED AN ADDITIONAL 293 INMATES WHO HAD COMPLETED THEIR SENTENCES. THESE INMATES WERE OFFENDERS SERVING SENTENCES FOR COMMITTING CHILD SEXUAL ABUSE CRIMES. (SEE TABLE 4 FOR MORE INFORMATION).
