Please find attached the **revised** 33rd Annual Report of *Child Sexual Abuse Statistics* submitted jointly by the Office of the Governor and the Office of the Attorney General.

The report has been revised due to a statistical error in the Department of Health & Welfare's Child Protection Referrals spreadsheet, which erroneously listed sexual abuse referrals screened into the Department at a frequency of 1,478 for FY2021. This statistic was referred to in the letter and on Page 7 of the original report. The actual number of referrals screened into the Department has been corrected to 801 for FY2021.
