Re: Notice of Data Event

Dear Sir or Madam:

We represent Carmel Clay Schools (“Carmel Clay School”) located at 5201 East Main St. Carmel, IN 46033, and are writing to notify your office of an incident that may affect the security of some personal information relating to one (1) Idaho resident. This notice may be supplemented with new significant facts learned subsequent to its submission. By providing this notice, Carmel Clay School does not waive any rights or defenses regarding the applicability of Idaho law, the applicability of the Idaho data event notification statute, or personal jurisdiction.

Nature of the Data Event

On February 24, 2021, CCS discovered suspicious activity involving employee email accounts. CCS immediately initiated a password reset to all CCS staff accounts in its environment. CCS promptly launched an investigation, with the assistance of third-party forensics specialists, to determine the nature and scope of this incident. We determined that employee email accounts may have been accessed without authorization between February 15 and February 24, 2021. In response, CCS undertook a diligent and comprehensive review of the entire contents of the email accounts involved in order to determine the type of information contained within the accounts and to whom that information pertained. On August 31, 2021, CCS completed its review of the impacted email accounts and confirmed that the accounts contained sensitive information. The information that could have been subject to unauthorized access includes name, address, driver’s license, and Social Security number.

Notice to Idaho Resident

On or about September 20, 2021, Carmel Clay School provided written notice of this incident to all affected individuals, which includes one (1) Idaho resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Carmel Clay School moved quickly to investigate and respond to the incident, assess the security of Carmel Clay School systems, and notify potentially affected individuals. Carmel Clay School is also working to implement additional safeguards and training to its employees. Carmel Clay School is providing access to credit monitoring services for one (1) year, through Equifax, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Carmel Clay School is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Carmel Clay School is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, information on protecting against tax fraud, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

NOTICE OF SECURITY INCIDENT

Dear <<Name 1>>:

Carmel Clay Schools ("CCS") is writing to inform you of a recent incident that may affect the privacy of some of your information. On August 31, 2021 CCS concluded its investigation and review of this incident and confirmed that you were an affected individual who required notice of the event. This notice provides information about the incident, our response, and resources available to help protect your information from possible misuse, should you feel it is necessary to do so.

What Happened? On February 24, 2021, CCS discovered suspicious activity involving employee email accounts. CCS immediately initiated a password reset to all CCS staff accounts in its environment. CCS promptly launched an investigation, with the assistance of third-party forensics specialists to determine the nature and scope of this incident. We determined that employee email accounts were accessed without authorization between February 15 and February 24, 2021. In response, CCS undertook a diligent and comprehensive review of the entire contents of the email accounts involved in order to determine the type of information contained within the accounts and to whom that information pertained. On August 31, 2021, CCS completed its review of the impacted email accounts and confirmed that the accounts contained information related to you.

What Information Was Involved? The investigation determined the impacted accounts included your name and <<Data Elements>>. While CCS has no evidence that your information was actually viewed by an unauthorized individual or misused, we are making you aware of this incident in an abundance of caution.

What CCS is Doing. CCS has strict security measures to protect the information in our possession and has worked to add further technical safeguards to our environment. Following this incident, CCS took immediate steps to increase the security of our environment.

As an added precaution, we are also offering you complimentary access to <<CM Length>> months of credit monitoring and identity restoration services, through Equifax. You will need to enroll yourself in these services if you wish to do so, as we are not able to activate them on your behalf. Please review the instructions contained in the attached *Steps You Can Take to Help Protect Your Personal Information* for additional information on these services.

What You Can Do. We encourage you to review the enclosed *Steps You Can Take to Help Protect Your Personal Information* for additional steps you may take and information on what you can do to better protect against the possibility of identity theft and fraud, should you feel it is appropriate to do so. We also encourage you to enroll in the complimentary credit monitoring services we are offering you.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
