Re: Notification of Data Security Incident

Dear Madam/Sir:

We represent Beyond 79, LLC ("Beyond 79"), in connection with an incident that involved the personal information of Idaho residents and provide this notice on behalf of Beyond 79 pursuant to IDAHO CODE § 28-51-105(1). This notice will be supplemented, if necessary, with any new significant facts discovered subsequent to its submission. While Beyond 79 is notifying you of this incident, Beyond 79 does not waive any rights or defenses relating to the incident or this notice, or the applicability of Idaho law on personal jurisdiction.

### NATURE OF THE INCIDENT

On July 18, 2022, Beyond 79 discovered that certain files were deleted from its systems. Upon discovery, Beyond 79 promptly began an investigation, notified law enforcement, and engaged a leading cybersecurity firm to determine the scope of the incident and confirm the security of its systems. In course of the investigation, it was determined that the unauthorized persons accessed Beyond 79's systems from July 11, 2022, to July 18, 2022, and deleted some customer personal information in certain file folders.

On September 8, 2022, Beyond 79 determined that the incident involved personal information which varied by customer but included names, addresses, Social Security numbers, driver's license numbers, and/or financial banking information. Beyond 79 is not aware of any fraud or identity theft to these individuals as a result of this incident.

## NOTIFICATION TO THE IDAHO RESIDENTS

Beyond 79 determined that the accessed file folders contained the personal information of three hundred ninety-six (396) Idaho residents. Beyond 79 is sending notification to individuals via email correspondence starting on October 28, 2022 and ending on November 1, 2022. The

notification letter includes information on ways the individuals can protect themselves against potential fraud and identity theft, as well as a telephone number they can call if they have any questions regarding the incident. For individuals whose Social Security and/or driver's license number were potentially involved in the incident the notification letter includes an offer for complimentary credit monitoring and identity theft protection. Enclosed is a sample of the notice sent to the Idaho residents.

# STEPS TAKEN RELATING TO THE INCIDENT

Upon discovering the incident, Beyond 79 engaged a leading forensic cybersecurity firm to assist in its investigation and to confirm the security of its computer systems. Beyond 79 has taken steps to reduce the risk of this type of incident occurring in the future, including enhancing its technical security measures. As discussed above, Beyond 79 is notifying the potentially involved individuals, providing free credit monitoring services, and providing the individuals with information on how they can protect themselves against fraudulent activity and identity theft.

Beyond 79, LLC values and respects the privacy and security of your information, which is why we are writing to advise you of a recent incident that may have involved some of your personal information stored in our systems. This email provides additional information about the incident and guidance on what you can do to protect yourself, should you feel it is appropriate to do so.

**What Happened?** We recently discovered that certain files were deleted from our systems. Upon discovery, we promptly began an investigation, notified law enforcement, and engaged a leading cybersecurity firm to determine the scope of the incident and confirm the security of our systems. As part of our investigation, it was determined that the unauthorized persons accessed our systems from July 11, 2022, to July 18, 2022, and deleted some customer personal information in certain file folders.

**What Information Was Involved?** On September 8, 2022, we determined that the incident may have involved unauthorized access to your personal information that included your name, driver's license number or state identification number, date of birth, Social Security number, and banking information.

What We Are Doing. We take the privacy and security of our customers' personal information very seriously. We have taken steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. Although we are not aware of any instances of fraud or identity theft involving your information, we are also offering a complimentary one-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. **Fraud Alerts:** You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. <u>Credit and Security Freezes</u>: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze can be placed without any charge and is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
